THEME OF THE CONFERENCE

The topic of this year's edition of Digital Legal Talks is again dedicated to law and digital technologies. In the context of this general theme, researchers are welcome to address various aspects that correspond to the main lines of research of the Digital Legal Lab.

These are:

1. Responsible data sharing and regulation of AI.
2. Digitalization of justice systems and dispute resolution.
3. Technology for law and legal practice.
4. Digital platforms as infrastructures and enforcers of public interests.
5. Enforcement and the use of technology (incl. DSA, DMA, AI Act, Data Act).
6. Data protection and cybersecurity.
7. Other: contributions targeting other topics in the field of law and technology are also welcome, but may receive less priority depending on the total amount of submissions.

HOW TO SUBMIT?

Please submit an extended abstract of your contribution of **1500 words max.** to **Oxford Abstracts**: The Digital Legal Lab will host the fifth edition of its annual conference Digital Legal Talks on **28 and 29 November in Utrecht!** It will be a fully in-person event. Accepted submissions in response to this call for papers will be scheduled for 28 November, and plenary sessions with invited speakers will be held on 29 November. **Please indicate to which of the abovementioned lines of research your submission relates and whether you wish to present it as a paper, or in a PLSC-style paper discussion, or whether it is a proposal for a panel. There are no specific guidelines as regards formatting or referencing style.**

The **deadline for submissions is 15 September** and the authors can expect **notification of acceptance by 4 October.**

We do **not require you to submit full papers** by the time of the conference, **unless** you wish to discuss them in a PLSC-style format. In that case, you will need to submit your **full paper to us on 4 November at the latest.**

Note that accepted submissions in response to this call for papers will be included in the program for 28 November. Plenary sessions with invited speakers will take place on 29 November.
